Swenson moved to approve the agenda. Moffitt seconded. Motion carried.

Moffitt moved to approve the minutes of the September 13, 2024 meeting. Driscoll seconded. Motion carried.

Britton reported on the Female Sale. Brandt moved to cancel the female portion of the bull test sale due to low numbers. Swenson seconded. Motion carried, 12 in favor and 3 opposed.
