Moffitt moved to approve the agenda. Swenson seconded. Motion carried.

Weber moved to approve the minutes of the March meeting. Driscoll seconded. Motion carried.

Brandt moved to approve the financial report of May 2025. Mobley seconded. Motion carried.

Moffitt reported on the IBBC notable items and future planning.

Britton reported on the activities of the secretary/treasurer and the ongoing preview weekend.

Chapman moved to select Bella Gotto as the exhibitor for the 2025 Iowa Governor's Charity Steer Show.

Schroeder seconded. Motion carried.

4 proposals were received and reviewed for sale management of the 2026 Iowa Angus sales.

Brandt moved to vote between Justin Stout and Danny Bradshaw. Moffitt seconded. Motion carried.

Justin Stout was selected as the 2026 sale manager for the Iowa Beef Expo sale.

Chapman moved to allow up to 15 fall bulls and 35 spring bulls in the 2025/2026 Iowa Angus Bull Test to be fed at Kirkwood Community College with delivery dates of September 9 and October 22. Mardesen seconded.

Motion carried.

Chapman moved to have no divisions or classes in the Iowa Beef Expo show. Mobley seconded. Motion failed 2-10.

Brandt moved to have class breaks, but only Grand Champion and Reserve are used for sale order. Swenson seconded. Motion passed 10-2.

Moffitt moved to allow out of state cattle to consign to the Iowa Beef Expo Angus sale with the requirement of purchasing an Iowa Angus membership. Chapman seconded. Motion passed 11-1.

Brandt moved to allow heifer/calf pairs. Chapman seconded. Motion carried.

Weston moved to hold the 2026 Iowa Angus Preview in Afton on Father's Day weekend. Schroeder seconded. Motion carried.

Lyle Herring and Bob Schlutz award recipients were nominated and approved.

Kurt Greiman reported on the junior activities, including 62 exhibitors and 162 entries for NJAS.

The next meeting will be held Monday night of state fair, with Caitlyn Brandt as a guest speaker.

Brandt moved to adjourn. Motion carried.
